CONDITIONS OF AGREEMENT: With two (2) inches of registered snow fall automatic disbursement of truck plows will occur and snow will be plowed within twelve (12) hours after precipitation has stopped. Equipment used for this contract will be front mounted plows. Any additional equipment and ice melting materials will be used only at client's request. Drive lanes will be first priority and unoccupied parking spaces to follow only if possible. Snow will be pushed into the most appropriate location available. Removal of snow is not included. Any changes to this agreement will be made in writing by the customer or its agent."

BLIZZARDS: With snow accumulations of more than eight (8) inches within twelve (12) hours. Larger equipment will be required such as skid steers and backhoes to pile or move snow. Larger equipment is disbursed only at clients request and in the order received.

Note: Equipment, melting materials & labor can be disbursed at client's requests (410-991-7813). When the contractor is asked to mobilize, the customer or its agent will advise the contractor whether or not the use of ice melt to concrete surfaces is authorized. The contractor will maintain the following types of insurance: worker's compensation, vehicle, and public liability. The contractor will provide customer of its agent evidence of insurance before commencing services and immediately upon any change, alteration or renewal of said policies."

EXCLUSIONS: Clearing snow from immediately behind and between vehicles is excluded. GMC Contractors, Inc. is excluded from responsibility to any interior damage caused by ice melting materials (such as: wood flooring, rugs etc...) or exterior damage (such as: curbing, signs, fencing etc...)

Varying elements of snow and ice storms are beyond the control or predictability of man, and therefore GMC Contractors, Inc. accepts no responsibility for injuries sustained to visitors or residents both pre and post snow clearance operations.

INVOICES: Billings for services will indicate: Date, hours, equipment, and materials used for each visit.

PAYMENT Invoices are due upon completion of work. Any payments received over 15 days are subjected to 2% interest per month. In case of default, collection fees and/or legal fees will be added under the Fair Debt Protection Practice. Any discrepancy between work performed and the amount billed must be addressed within 48 hours upon client receiving invoice.
